The homes provide round-the-clock assisted living, HIV specific meals, nurse, case management and hospice services. During the year, care was provided to 53 clients.

4b (Code:) (Expenses \$ 2,518,238. including grants of \$ 1,998,831.) (Revenue \$ 164,466.) Permanent housing in 135 furnished rental units (CHOISS). Permanent supportive housing to homeless multi-diagnosed persons living with HIV/AIDS and their families. CHOISS is a scattered site leasing program with units throughout Los Angeles County. During the year, care was provided to 157 clients, and 102 family members for a total of 259 persons.

4c (Code:) (Expenses \$ 933,571. including grants of \$ 1,012,318.) (Revenue \$) Short-term Rent, Mortgage, & Utility program (AFA STRMU & Move in). Provides permanent and temporary supportive housing to homeless and impoverished multi-diagnosed persons living with AIDS/HIV. During the year, 505 clients were served with grants.
