The homes provide round-the-clock assisted living, HIV specific meals, nurse, case management and hospice services. During the year, care was provided to 50 clients.

4b (Code:) (Expenses \$ 2,869,680. including grants of \$ 1,956,388.) (Revenue \$ 201,448.) Permanent supportive housing in 148 master-leased, furnished rental units scattered throughout Los Angeles County. The program provides subsidized housing with in-home support for homeless, multi-diagnosed persons living with HIV/AIDS and their families. During the year, care was provided to 162 clients, and 90 family members for a total of 252 persons.

4c (Code:) (Expenses \$ 1,039,066. including grants of \$ 765,445.) (Revenue \$) The Short-term Rent, Mortgage, and Utility Assistance and Permanent Housing Placement program provides temporary financial assistance to homeless and unstably housed low income persons living with HIV/AIDS. During the year, 848 clients were served.
