The homes provide round-the-clock assisted living, HIV specific meals, nurse and case management. During the year, care was provided to 41 clients.

4b (Code: ) (Expenses \$ 3,090,408. including grants of \$ 2,051,693. ) (Revenue \$ 213,370. ) Permanent supportive housing in 148 master-leased, furnished rental units scattered throughout Los Angeles County. The program provides subsidized housing with in-home support for homeless, multi-diagnosed persons living with HIV/AIDS and their families. During the year, care was provided to 144 clients, and 69 family members for a total of 213 persons.
